

MANAGERS & AGENTS

SELF-PETITION GREEN CARDS



Sherrod Sports Visas services EB1A visa petitions for athletes that can prove extraordinary abilities. The EB1A visa does not require a labor certification which consists of an approval from the Department of Labor after the position is advertised to the public. Since the EB-1 does not require a labor certification, the timing is much shorter than both EB-2 and EB-3 visas. The first part of the process which involves getting approved as an alien with extraordinary abilities takes about 7-8 months for USCIS to process and approve. The permanent residence or Green Card portion of the process can take one to three years.

The athlete must meet 3 of the listed criteria below to prove extraordinary ability in the sport:

- Evidence of receipt of lesser nationally or internationally recognized prizes or awards for excellence
- Evidence of membership in associations in the field which demand outstanding achievement of their members
- Evidence of published materials about the athlete in professional or major trade publications or other major media
- Evidence of judging the skills of others, either individually or on a panel
- Evidence of original athletic, or business-related contributions of major significance to the field
- Evidence of performance of a leading or critical role in distinguished organizations
- · Evidence of high salary or other significantly high remuneration in relation to others in the field

SPOUSES AND CHILDREN

Non-immigrant visa holders can apply for derivative visas for their spouse and children. These visas will last for the validity period of the non-immigrant visa. They do not provide work authorization but the family member can take classes.
